Explanation of Responses:

- (3) The restricted stock units vest on various dates ranging from August 22, 2006 to March 16, 2009. The total amount includes restricted stock units that were acquired since the reporting person's last report reflecting ownership of restricted stock units. Those units were acquired pursuant to automatic dividend reinvestments that were exempt from reporting pursuant to Rule 16a-11.
- (4) The option vests in four equal annual installments beginning on March 16, 2007.
