Explanation of Responses:

(1) On December 19, 2008, the reporting person was granted an option to purchase 250,000 shares of common stock scheduled to vest in installments of 3.3332%, 20%, 20%, 20%, 20% and 16.6668% per year based on the Issuer's satisfaction of certain performance criteria for each of the 2008 through 2013 fiscal years. The performance criteria for each of the 2008 and 2009 fiscal years were met, resulting in the previous vesting of the option as to 8,333 and 50,000 shares, respectively. The option reported herein as acquired resulted from the acceleration of vesting of .1668% of the option granted on December 19, 2008 as a result of a secondary offering of shares of common stock by certain of the Issuer's shareholders. The number of securities reported in this column also includes 250,000 options, whether or not vested, that are subject to time-vesting criteria but have the same exercise price and expiration date as the option reported herein as acquired.
