Explanation of Responses:

(1) On July 6, 2007, the reporting person was granted an option to purchase 192,857 shares of common stock. The option vests in installments of 20% per year based on the Issuer's satisfaction of certain performance criteria for each of the fiscal years ended or ending February 1, 2008, January 30, 2009, January 29, 2010, January 28, 2011, and February 3, 2012. The performance criteria for each of the fiscal years ended February 1, 2008, January 30, 2009 and January 29, 2010 were met, resulting in the vesting of the option as to 38,572, 38,572 and 38,571 shares, respectively. The number of securities reported in this column also includes 192,857 options, whether or not vested, that are subject to time-vesting criteria but have the same exercise price and expiration date as the options reported herein as acquired.
