Explanation of Responses:

- (2) The RSUs vest and become payable ratably in three annual installments beginning on March 23, 2008.
- (3) The RSUs vest on various dates ranging from September 18, 2007 to March 23, 2010, although certain of the RSUs generally are not payable until the reporting person ceases to be employed by the issuer.
- (4) The option vests in four equal annual installments beginning on March 23, 2008.
