- (1) Restricted stock units representing the right to receive shares of common stock upon vesting. The restricted tock units vest in three annual installments of 33 1/3% beginning on April 1, 2016.

- (3) Shares of common stock surrendered to the Issuer in payment of taxes in connection with the vesting and payment of restricted stock units granted on March 18, 2013 (595 shares) and March 18, 2014 (473 shares), as well as the vesting and payment of a portion of performance share units granted on March 18, 2013 (234 shares).
- (4) The option vests in four annual installments of 25% beginning on April 1, 2016.
