Explanation of Responses:

- (1) Restricted stock units which represent a contingent right to receive shares of common stock upon vesting. The restricted stock units vest in three equal installments on each of the first, second, and third annual shareholders' meetings of the Issuer immediately following the transaction date.
- (2) The option vests in four annual installments of 25% beginning on November 18, 2010.

Remarks:

Mr. Agrawal, an executive of Kohlberg Kravis Roberts & Co. L.P. ("KKR") and/or one or more of its affiliates, is a member of the Issuer's board of directors. Certain affiliates of KKR have separately reported securities of the Issuer that they may be deemed to beneficially own. Mr. Agrawal disclaims beneficial ownership of any securities of the Issuer that may be deemed to be beneficially owned by affiliates of KKR.
