#### **Explanation of Responses:**

- (1) The restricted stock units convert to shares of common stock on a one-for-one basis.
- (2) The restricted stock units vest and become payable in three equal annual installments beginning on March 15, 2006.
- (3) The restricted stock units vest on various dates ranging from August 24, 2005 to March 15, 2008. The total amount includes 21.45 restricted stock units that were acquired since the reporting person's last report reflecting ownership of restricted stock units. Those units were acquired pursuant to automatic dividend reinvestments that were exempt from reporting pursuant to Rule 16a-11.
- (4) The option vests in four equal annual installments beginning on March 15, 2006.
